**ORDER:**

In the reference 1<sup>st</sup> read above, the Director, HFW has furnished the proposal for restructuring of staffing pattern of APVVP facilities of different bed strength in the State under the administrative control of APVVP and Upgrading / Downgrading / Converting certain posts under control of APVVP to provide better outreach and Health Delivery Services and requested to issue necessary orders in the matter.

2. Accordingly, orders have been issued in the G.O.s second read above for restructuring the staffing pattern for APVVP facilities of different bed strength in the State.

3. Consequent to the restricting orders issued in the G.Os 2<sup>nd</sup> read above, the Govt., after careful examination of the matter, hereby upgrade/downgrade/ convert the following posts under the control of APVVP:

- i. Downgrading 121 CSS (Civil Surgeon Specialist) posts to that of DCS-S (Deputy Civil Surgeon - Specialist) and DCS-GE (Deputy Civil Surgeon - General)
- ii. Converting 5 CSS posts as Civil Surgeon - Dental.
- iii. Upgrading 330 (CAS-S and CAS-GE) to that of DCS-S and DCS-GE.
- iv. Keeping 14 posts of CAS in Central pool for PG Lein.
- v. Upgrading 153 Pharmacist Grade-II posts to that of 107 posts of Pharmacist Grade-I and 46 posts of Pharmacy Supervisor.

4. The Commissioner, APVVP shall take further necessary action to designate the Doctor posts as per the above restructuring.

5. The Director of Health & Family Welfare, AP.,/the Commissioner, APVVP shall take further necessary action accordingly.
