ORDER:

In the reference 3rd read above, the Director, H&FW, AP., has furnished the proposal for revising the staffing pattern of APVVP facilities of different bed strength in the State under the administrative control of APVVP and to upgrade / Downgrade/Convert certain posts under control of APVVP to provide better outreach and Health Delivery Services and requested to issue necessary orders in the matter.

2. Accordingly, in the G.Os, 4th read above, orders have been issued revising the staffing pattern of all Health facilities of APVVP in supersession of the earlier orders issued in the G.Os 1st read above.

3. Consequent to the revised restructuring orders issued in the G.Os 4th read above, Government after careful examination of the matter, hereby upgrade/downgrade/ convert the following posts under the control of APVVP:

- i. Upgrading DCS Posts to that of 91 CSS posts and downgrading to that of 169 CAS [168 CAS-S + 1 CAS-General] posts from the posts of 260 DCS [234 DCS-S + 26 DCS-General] respectively.
- ii. Converting the posts of 11 CS-RMOs & 42 CS-Dental as CSS posts.
- iii. Upgrading 25 Senior Assistant posts to that of 25 Office Superintendent posts.

4. The Government also hereby accord permission to the Commissioner, APVVP for redeployment of the staff in view of the revised restructuring the Hospitals of APVVP issued in the G.Os. 4th read above.

5. The Director of Health & Family Welfare, AP./the Commissioner, APVVP shall take further necessary action accordingly.
