In G.O.Ms.No.2513, Health, dated 16.9.1963, orders were issued extending the concession of 30 days casual leave, weekly offs and eight (8) hours duty to the employees working in the Institutions of Medical and Health Department, subject to the conditions mentioned in para 1 of their order.

2. In May, 1975 the Director of Medical and Health Services has submitted a proposal on a representation from the Andhra-Pradesh Medical Employees Union, Hyderabad that the employees working in the hospitals may be given 50 days casual leave instead of 30 days casual leave. The proposal was examined and it was negatived with Memorandum No.2840/HE-2/74-2, Health, dated 8-5-1975.

3. The Andhra Pradesh Medical Employees Union has requested for extending the concession of casual leave to 60 days for the employees working in Hospitals in view of the recent change of working hours of offices from 7-30 A.M. to 2-15 P.M. and two weekly holidays.

4. The Director of Medical Education, who has been consulted in the matter, has recommended for the enhancement of casual leave to all para Medical Staff of Medical & Health Department from 30 to 35 days as already agreed upon in the meeting with the representatives of the Andhra Pradesh Medical Employees Union, Hyderabad.

5. The Government after careful consideration has decided to extend the concession of 35 days casual leave with weekly off for one day and eight (8) hours duty to the employees working in the institutions of Health & Medical Department, subject to the conditions stipulated in para 1 of the G.O. first cited.

6. This order issued with concurrence of Finance & Planning (F.R.I) Department vide their U.O.No.52754/1136/P.R.I, dated:30.11.79.

In the reference (1)st Cited, orders were issued that
contingent employees should be granted Casual Leave upto the
limit of 30 days in a year and weekly offs on par with the
regular employees. Government have since enhanced the casual
leave of regular employees from 30 days to 35 days in a year
with weekly offs vide G.O.2nd cited.

Hence the following revised orders are issued.

All the contingent employees in the Medical and Health
Department, who are already enjoying 30 days casual leave
with weekly offs are now eligible for 35 days Casual Leave
in a year with weekly offs on par with the other Government
Employees.

Temporary contingent employees should also be granted
casual leave proportionately for the service rendered by them
in a particular year as in the case of other temporary Government
employees.

The above instructions should be followed strictly.


