The G.O. first read above, Andhra Pradesh Medical Subordinate Service Rules are issued for various class / categories and posts.

2. In the reference second read above, the Government have issued amendment orders, to the Service Rules, on appointment of certain posts, in Health Medical & Family Welfare Department including the cadre of Pharmacist-Gr.II.
3. In the reference third read above, the Director of Public Health & Family Welfare, Andhra Pradesh, Gollapudi has submitted the proposals for re-organisation of local cadre in respect of the post of the Pharmacist Gr.II from district cadre to Zonal cadre.
4. In the reference fourth read above, the Government of India vide their letter dated 16.01.2019 have informed that the matter of re-organisation of local cadre has been considered in consultation with Ministry of Law and Justice and it has been observed that the Presidential Order dated 18.10.1975 has Unambiguous provisions in regard to Pharmacist Grade II.

In view of the circumstances explained above, after careful examination of the matter the Government hereby decided to make amendment to the Andhra Pradesh Medical Subordinate Service Rules issued in G.O.Ms.No.727, MH & MA Department dated 26.03.1965 and subsequently as amended from time to time and accordingly the following notification will be published in the Andhra Pradesh Gazette:-
